- ▶ PAINT, CAULK, GLAZING, PAINT THINNER, CARPET CEMENT, CREOSOTE OR THEIR CONTAINERS.
- ▶ FOOD
- ▶ LIQUIDS
- ▶ DRUMS
- ▶ TAR OR TAR CONTAINERS
- ▶ MORE THAN 10% PAPER PER LOAD
- ▶ CREOSOTED RAIL ROAD TIES
- ▶ FIBERGLASS TANKS
- ▶ BOATS
- ▶ SEWAGE OR SEPTAGE
- ▶ FUEL TANKS OR CONTAINERS
- ▶ SAND, BLASTING SAND
